

2025 Annual Activity Report

Human-rights documentation, institutional engagement, awareness and social participation.

About this report

This report presents a concise institutional account of SRL Swiss activities during the reporting year. It focuses on human-rights documentation, research, advocacy, institutional engagement, public information and community participation. Financial figures are not included in this edition.

Where an activity has a public page, report or submission on the SRL Swiss website, a reference is provided at the end of this report. Other activities are described from the Association's internal annual activity records.

Year in Review

In 2025, SRL Swiss continued its work in human-rights documentation, research and advocacy while strengthening institutional communications and activities supporting social participation in Switzerland.

The Association brought documented concerns to the attention of relevant institutions, developed public reports and submissions, continued awareness activities and worked to improve the accessibility of its publications.

Human Rights Documentation and Advocacy

SRL Swiss examined a range of human-rights and rule-of-law issues during 2025. Publicly documented work included reporting on the impact of the Maydanöz Döner operation on people dismissed from public service under emergency decrees, documentation concerning pressures on the children of dismissed public servants, and a communication to the Grand National Assembly of Türkiye concerning rule-of-law and human-rights concerns.

The Association also published a case report on the death in custody of Mustafa Kabakçioğlu, focusing on the right to life, access to health care and the protection of persons deprived of liberty.

Institutional Engagement

SRL Swiss continued communications with international and Swiss institutions on human-rights and protection issues. Internal activity records also include correspondence concerning the use of INTERPOL mechanisms and an individual family-reunification matter in Switzerland.

Where public documentation is available, it is listed in the reference section below. Individual correspondence is not reproduced where privacy or confidentiality considerations apply.

SRL Talks, Information and Awareness

The Association continued the SRL Talks series and information activities addressing human rights, social exclusion, radicalisation, torture and ill-treatment. It also organised practical information sessions aimed at supporting participation in working life in Switzerland.

These activities complemented SRL Swiss's research and reporting work by creating spaces for discussion, awareness and knowledge-sharing.

Social Participation and Solidarity

SRL Swiss organised and supported community and solidarity activities in Switzerland, including gatherings, visits and consultation activities. In public reporting, the Association sought to protect the privacy of individuals and families receiving support or advice.

Institutional Communication and Governance

During 2025, SRL Swiss continued to develop its website, publication structure and public communication. The Association's work remained organised through its General Assembly, Board of Directors and oversight function.

Activities were supported primarily through member contributions and voluntary support. This edition of the activity report does not include financial figures.

Looking Ahead

SRL Swiss aims to continue strengthening its research and reporting capacity, engagement with international human-rights mechanisms, institutional cooperation and the accessibility of its publications.
